# Kidnapped CARE roadside signs discovered in FirstEnergy vehicle

### What is a 'merit brief'?

**Legal briefs** are formal legal arguments presented to the Court after it as agreed to take a case.

power corridor utilizing hundreds of privately-owned properties unless the Ohio Power Siting Board independently concludes that a Certificate should be issued. Because the Board delegated its decision making responsibility to the ALJ, no such independent determination occurred below. Further, the Order contains no analysis or consideration of the arguments and evidence presented.

Moreover, public proceedings such as these should not countenance the shielding of critical evidence from public view. Applicants have sought a Certificate that would grant them the power of eminent domain. When asking for such authority, the attempt to shield critical information from public view should not be tolerated. Here, the withholding of information was not

only tolerated, it was a rewarded tactic.

The Board's flagrant disregard for the administrative process and the duties imposed by statute should not be allowed, especially where, as here, the rights Ohio citizens to resist the use of eminent domain power by a for-profit company hang in the balance. As this Court noted in *City of Norwood v. Horney*, there is a growing debate about the use of eminent domain to acquire property for private economic interests and the courts therefore have an increasing role "in safeguarding the rights of private property owners who fear that the takings power will be used solely to benefit private interests." 2006-Ohio-3799 at ¶ 136. Because it is entrusted with this constitutionally-required "public need" determination, the Board has just such an obligation. As demonstrated above, the Board did not discharge this obligation with the same respect and due process as would have been accorded CARE by a court of law, and the Board's unlawful delegation, its disregard of relevant evidence, its shielding of important information from the public, and its acquiescence in Applicants' dilatory discovery tactics render the Order unlawful and unreasonable.

Accordingly, this Court should reverse and vacate the Board's November 24, 2008 Order, Opinion and Certificate.

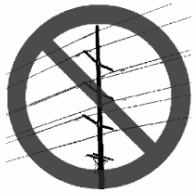

### CARE warns landowners It's NOT Over! Do not sign!

Under the law, FirstEnergy representatives are permitted to enter properties along the approved route to conduct survey operations, but, even if the Ohio Supreme Court should rule against CARE, no actual construction work can proceed until the company has acquired easements from property owners.

Jim Galm, CARE's president, is reminding members and residents along the OPSB-approved route: "It's very important to keep our eyes on the ball at this point. FE will be trying to persuade us that the process is over and that signing the easement contract is our only option. Bullroar. The certificate of environmental compatibility and public need that PUCO granted to FE is presently under litigation in the Supreme Court of the State of Ohio, thanks to the undying perseverance of CARE members and the incomparable professional service and support that we have received from our legal team and their law firm, Taft, Stettinius and Hollister.

Make no mistake friends and neighbors. It's not over."
