**CARE warns landowners
 It's NOT Over !
 Do not sign !**

Under the law, FirstEnergy representatives are permitted to enter properties along the approved route to conduct survey operations. **Even if the Ohio Supreme Court rules against CARE, no actual construction work can proceed until the company has acquired easements from property owners.**

Jim Galm, CARE's president, is reminding members and residents along the OPSB-approved route: "It's very important to keep our eyes on the ball at this point. FE will be trying to persuade us that the process is over and that signing the easement contract is our only option. Bullroar. The certificate of environmental compatibility and public need that PUCO granted to FE is presently under litigation in the Supreme Court of the State of Ohio, thanks to the undying perseverance of CARE members and the incomparable professional service and support that we have received from our legal team and their law firm, Taft, Stettinius and Hollister.

Make no mistake friends and neighbors. **It's not over!"**

Meanwhile, CARE members are focusing on the main task at hand, raising cash for the Defense Fund to pay the considerable expense of last year's efforts to defeat the OPSB application as well as the cost of the Supreme Court appeal. Nearby is a listing of scheduled activities in the rest of 2009, and all of 2010. CARE members greatly appreciate the way the Geauga community, not to mention our many good friends elsewhere, has supported its various fundraising efforts. A message from James M. Galm, president of CARE

Dear Neighbors and Friends,

I would like to take this opportunity to thank every CARE benefactor, member, officer, committee member, friend, and sponsor for their help and support over the last two and a half years. Without your support and perseverance, CARE would not be the organization that it is today.

When FirstEnergy proposed the Geauga 138 kV Transmission Line Supply Project in March 2007, it was obviously a horribly irresponsible project and a bad solution to FirstEnergy's electrical problems in Geauga County. Nearly everyone in northeast Ohio was opposed to the project.

One by one, FirstEnergy began acquiring the support of politicians and businesses. Witness the about-face of the Geauga County Commissioners away from their constituents and toward FirstEnergy. The support of township trustees outside of the affected areas, originally pledged to CARE, mysteriously waned after visits from FirstEnergy.

FirstEnergy employed the well-known tactic of trying to pit communities against each other to weaken opposition to their plans. FirstEnergy's carefully orchestrated plan of turning Chardon against the northeast townships certainly caused Chardon to spend a great deal of money in opposition to our cause.

FirstEnergy has continued their tactic of trying to wear down landowners with repeated visits from their real estate representatives. Sporting terribly unfavorable contracts and paltry sums of money, the FirstEnergy minions have canvassed our neighborhoods for months looking to prey on our neighbors.

CARE followed all of the rules, worked relentlessly, and mounted a fantastic legal defense against FirstEnergy. CARE based its case on inarguable facts, sound law, and the testimony of technical experts and dozens of concerned citizens. CARE presented a winning case to the Ohio Power Siting Board in the last half of 2008. To our dismay and horror, the Ohio Power Siting Board ignored the case record and "rubber stamped" FirstEnergy's project in a six-minute meeting in Columbus. CARE's appeals to the Ohio Power Siting Board fell on ears made deaf to facts, law, and reason.

CARE has now have taken the Public Utilities Commission of Ohio before the Ohio Supreme Court, to obtain justice. The Public Utilities Commission of Ohio violated the constitutional rights of Ohio's citizens to due process and fair hearing by ignoring the case record and allowing the Ohio Power Siting Board to issue a construction certificate to FirstEnergy in error. It is the duty of the Justices of the Ohio Supreme Court to realize and correct the error committed by the PUCO.

We now face the challenge of raising the funds to pay for this incredible fight. These are very difficult times to raise funds for any project, and raising funds for CARE has been no exception. I am personally asking everyone to be as generous with your donations, time, and support as you can possibly be. CARE needs your support even more now than it did back in March 2007.

Friends and neighbors, this has been a long and exhausting fight against FirstEnergy and the PUCO. These organizations have unlimited resources and many friends in politics. CARE, on the other hand, has the truth, the facts, absolute credibility, and the unyielding spirit of dedicated members and friends.

Working together, we will prevail.
