CARE takes power line case to the Ohio Supreme Court

Notice of Appeal filed March 13

"Appellant, Citizens Advocating Responsible Energy ("CARE"), hereby gives notice of its appeal, pursuant to R.C. 4903.11 and 4903.13, to the Ohio Supreme Court, from the Opinion, Order and Certificate of the Ohio Power Siting Board ("OPSB"), entered on November 24, 2008 in OPSB Case No. 07-0171-EL-BTX."

These are the opening words from CARE's notice of appeal filed March 13 with the Ohio Supreme Court.

CARE now has Ohio Supreme Court case number 2009-0481 and the case status is OPEN. The web page for Ohio Supreme Court case number 2009-0481 is on line (visit www.caregeauga.org/court.html). The notice of appeal appeared the same day on the PUCO case docket.

"The next phase in our fight to preserve and protect the cherished communities of northeast Geauga County officially begins now.

"Make no mistake, working together, CARE will prevail in this case before the Ohio Supreme Court," said Jim Galm, president of CARE.

CARE complains

The appeal states:

"CARE's Application for Rehearing was denied by the OPSB by entry dated January 26, 2009. The OPSB's November 24, 2008 Order, and its January 26, 2009 Entry on

Rehearing are unlawful, unjust, and unreasonable in the following respects:

"1. The OPSB improperly delegated its authority to render an opinion to the Administrative Law Judge.

"2. The OPSB relied on information outside of the record in reaching its decision.

"3. The OPSB's reliance on the Staff Report violates CARE's right to due process.

"4. The OPSB ignored its previous adjudication in Case No. 95-0600-EL-BTX, in which the OPSB granted to certificate to build an electrical transmission line to satisfy the same electrical need as the instant project.

"5. The OPSB failed to consider that the obstructionist tactics of the Applicants, American Transmission Systems Incorporated and the Cleveland Electric Illuminating Company, prevented CARE from fully and adequately preparing for the adjudicatory hearing.

"6. The OPSB's Order is unlawful and unreasonable because the OPSB ignored the Administrative Law Judge's decision to shield key documents and key witness testimony from the public in violation of the Ohio Sunshine Law.

Requests reversal

"Accordingly, CARE respectfully submits that the OPSB's November 24, 2008 Order and its January 26, 2009 Entry on Rehearing are unlawful, unjust, and unreasonable and should be reversed by this Court and should be remanded to the OPSB with instructions to correct the errors complained of herein."

Ruling may wait 'til fall

The *Geauga County Maple Leaf*, in a story published March 19, reports comments by FirstEnergy spokesman Mark Durbin in which he told the *Maple Leaf* that CARE's appeal to the Ohio Supreme Court was not unexpected, and predicted the court would uphold the siting board's decision. A ruling may not come until early this fall because of the various legal matters involved in the case, he further said.

CARE warns Route 528 landowners:

Do NOT sign !

Even though CARE has appealed to the Ohio Supreme Court to overturn the OPSB ruling granting FirstEnergy the right to construct a new power line along its proposed "overland route," representatives of FirstEnergy/ATSI can be expected to continue contacting landowners along Rt. 528 with a "Right of Way Option" contract, and encouraging them to sign it.

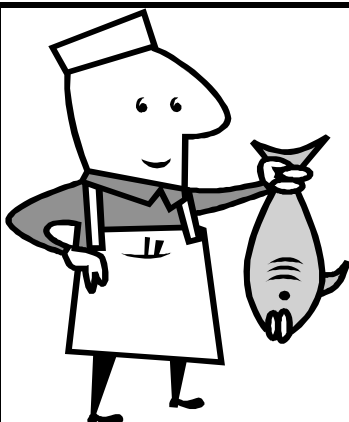
A right of way option means that FirstEnergy/ATSI wants to "lock in" their ability to purchase a right of way through property at some later time, for a pre-determined price. When FirstEnergy/ATSI buys a right of way option, the companies give the landowner a money payment in exchange for the option to buy a right of way easement at some date in the future. The option expires in two years. If FirstEnergy/ATSI exercises its option within two years, it gives the land owner an additional payment and the landowner grants the companies a right of way through his or her property.

This is an extremely unfavorable contract from the landowner's point of view. It is a one-sided agreement that gives the companies free rein, and the land owner almost nothing in exchange. Don't take CARE's word for it — have any attorney read this contract and give their opinion.

Two general rules that apply whenever someone brings you a contract and encourages you to sign it:

Absolutely, positively never, ever sign any contract without having it examined by an attorney that you pay for their services. Free legal advice is worth every cent you pay for it. You are under no obligation to sign any contract until you have had it reviewed and considered the consequences. Most lawyers will provide this service for a nominal fee.

Remember that if someone encourages you to sign a contract, it must benefit them more than it benefits you. The more they want you to sign, the more you probably stand to lose.
